A Record of Knowledge Mobilization in the *Civil Justice System and the Public* English Version Final update November 2010

The *Civil Justice System and the Public* is a collaborative action research project. As such the knowledge mobilization and sharing activities extend far beyond publications and formal presentations about “results.” Our knowledge mobilization began with getting the word out about the project to key contacts in the justice community, and then again to representatives of those organizations in our research sites across Canada. Activities by letter, email, telephone, in-person meetings and informal presentations have continued throughout the project and are far too numerous to list.
